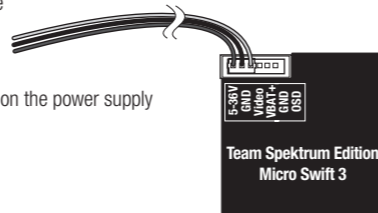

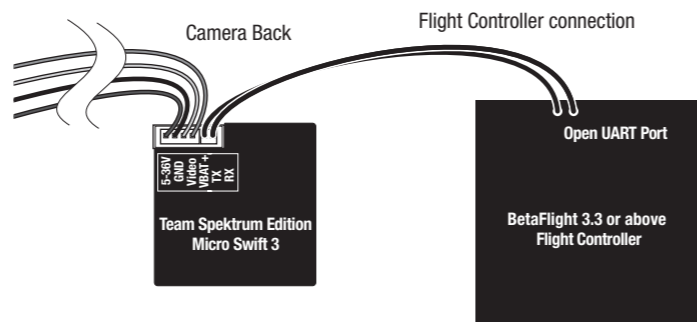
CAMERA TO VIDEO TRANSMITTER CONNECTION

1. Connect the 5-36V wire to the positive side of the power source
2. Connect the GND wire to the negative side of the power source (ground).
3. Connect the VBAT wire to the positive wire on the power supply for the OSD voltage reading.



BETAFLIGHT OSD PROGRAMMING

- VBAT+ (Blue)
- Video out (Yellow)
- Ground wire (Black)
- DC 5–36V in (Red)
- Brown and Green (UART)



1. Connect the 5-36V wire to the positive side of the power source
2. Connect the GND wire to the negative side of the power source (ground).
3. Connect the VBAT wire to the positive wire on the power supply for the OSD voltage reading.
4. Connect the Tx on the camera to the Rx on the flight controller, and open flight controller UART connection. Connect the Rx on the camera to the Tx on the camera, on the same UART.
